## Rules for the Annual Exhibitions

1. The structure of the Annual Exhibitions shall be as follows:-

2. **DEFINITIONS**

**Pictorial:** - Photographs which depend mainly on composition, lighting and mood. This may include creative images.

**Record:** - Photographs of inanimate objects showing essentially shape and detail. Pictorial composition is not a consideration in this section.

The environment surrounding the subject shall be confined to that necessary to the main subject which is to be displayed, i.e. Environment not to overpower the subject!

Inanimate describes a non-living thing. Furniture, buildings, objects are all inanimate.

**Portrait:** - Photographs of people only. No animal portraits.

**Action:** - Photographs must suggest movement and the main emphasis should be on human or vehicle activity, etc.

No Water Falls etc. No Nature Images.

**Monochrome:** - Photographs must be in black and white with various shades of grey. A black and white photograph toned entirely in a single colour remains monochrome.

**Nature:** - Photographs depicting living, untamed animals and uncultivated plants in their natural habitat, geology and the wide diversity of natural phenomena, from insects to icebergs, but excluding domesticated, restrained or caged animals and cultivated plants. Human elements shall not be present except on the rare occasion that they enhance the story. Any manipulation is limited to minor retouching of blemishes and must not alter the content of the photograph.

4. Each exhibitor shall complete an entry form. A maximum of 6 prints and/or 4 projected images can be entered by each member, with no more than two in any section that is open to all members.

5. The judge will be asked to give First, Second and Third place awards in each section plus Highly Commended and Commended awards at his/her discretion.

6. Prints may be of any size on mounts of not less than 25 cm x 20 cm and not more than 50cm x 40 cm and shall bear a title only on the back and no entrant's name. Electronic images should be in the format posted at the start of the season by the Competition Secretary and be no bigger than 1600 x1200 pixels.

7. Photographs entered in any previous Annual Exhibition, or any significantly similar, are not eligible for entry into any section of any subsequent Annual Exhibition.
